

ZONG Privacy Policy

Personal Information

Using ZONG services will require you provide to ECHOVOX certain personal information so that ECHOVOX can provide you with the best service possible. For the good performance of the ZONG service, ECHOVOX will request you to provide your address, a phone number, a valid e-mail and in order to pay you, your banking details (hereafter the Personal Information).

Use of Your Personal Information

The Personal Information you provided us won't be transmitted to any third party without your prior consent. ECHOVOX may use your personal data (mainly phone numbers and email) for communication, support and invoicing (should it be the case) purposes.

General and access

ECHOVOX may disclose personally identifiable information in response to legal process, for example, in response to a court order or a subpoena. We also may disclose such information in response to a law enforcement agency's request, or where we believe it is necessary to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of our terms of use, to verify or enforce compliance with the policies governing ZONG website and applicable laws or as otherwise required or permitted by law or consistent with legal requirements.

Disclosing

ECHOVOX reserves the right to access and disclose your Personal Information to comply with laws, subpoena and lawful government requests, to operate its systems properly, to protect other ZONG users or third parties. ECHOVOX may also reserve the right to disclose individually identifiable information to third parties where a complaint arises concerning your use of the ZONG service, and that use is deemed inconsistent with the ZONG Terms & Conditions.

Information Protection

ECHOVOX protect Personal Information received by establishing appropriate physical, electronic and managerial procedures to safeguard the information we collect. This helps prevent unauthorised access, maintains data accuracy and ensures that the information is used correctly.

Cookies

A cookie is a piece of information that is deposited by the ECHOVOX computer server when you visit ZONG website which is stored on your computer's hard drive by your web browser. On revisiting ZONG website, the ECHOVOX' server will recognise the cookies, giving ECHOVOX information about your last visit. Most browsers accept cookies automatically, but usually you can alter the settings of your browser to prevent automatic acceptance.

IP addresses

Every time you connect to ECHOVOX's website, web server logs will be stored which show your IP address (the unique number which your machine uses when it is connected to the Internet); what you looked at; whether the page request was successful or not, and which browser you used to view the pages. The use of this data is strictly for statistical purposes and personalisation purposes only. This helps ECHOVOX understand where you come from, which areas of the site are of particular interest and also which pages are not being requested.

How You can Access or Correct Information

Access to personally identifiable information that is collected from our sites may be accessible from the point of collection. For example, once you have created a password-protected account within ZONG.com, you can access that account to review the information you provided.
